Nominees for this award should have served, participated or made a contribution in all three of the following categories - Civic, Service, and Economic. Recipients of this award must be accomplished in their service to the Wellington area community.

The following criteria should be used as a guideline for nominations, however, any other outstanding accomplishment or achievement may be added. It also should be noted that someone who has been nominated in the past, but not chosen, may still be eligible for nomination. The **Distinguished Service Award (DSA)** Committee, comprised of the three most current Past Presidents and two most current DSA recipients, will make the final selection.

- ♦ **Civic includes:** City and county, planning commission, park board, library board, housing authority, airport advisory board, chamber of commerce board, committee or other community promotions; hospital board, school board, youth organization, parent teacher association, sports or extra-curricular activities.
- ♦ **Service includes:** Clubs, organizations, for example - trade, skill, music groups, theater group, museum, food bank, senior center, etc.
- ♦ **Economic includes:** Sumner County Economic Development Commission, farm groups, energy groups or other economic entities.
